**ORDINANCE NO. 367
AN ORDINANCE AMENDING CHAPTER 15 – TOWN COUNCIL**

Section 1. The Town Council of the Town of Charlestown hereby ordains that Chapter 15 of the Code of Ordinances, Town of Charlestown entitled Town Council, is amended, as follows:

§15-14. Order of Business

The order of business at each meeting ~~shall be as follows~~ may include the following:

- ~~11.~~ ● Ordinances and Resolutions
- ~~12.~~ ● Communications and Petitions
- ~~13.~~ ● Licenses and Permits
- ~~14.~~ ● Persons Wishing to be Heard
- ~~15.~~ ● Appointments and Resignations
- ~~16.~~ ● Fiscal Matters
- ~~17.~~ ● Legal Matters
- ~~18.~~ ● Unfinished Business
- ~~19.~~ ● New Business
- ~~20.~~ ● Adjournment (10:00 pm curfew unless voted otherwise)

The Town Council, upon taking office at the first regularly scheduled Town Council meeting, ~~shall~~ may adopt a “Council Agenda” to include, but not be limited to the “order of business” contained in §15-14 of the Code. Each new Town Council ~~shall~~ may adopt the order in which the Council business is conducted and if deemed appropriate, and additional subcategories of Council business as it deems necessary to conduct the business of the Council.

Section 2. The Town Clerk is hereby authorized to cause said changes to be made to Chapter 15 of the Town of Charlestown’s Code of Ordinances.

Section 3. This ordinance shall take effect immediately upon passage.
