REQUIREMENTS FOR BUILDING DEMOLITION PERMITS

The following documentation is required to obtain a demolition permit:

- 1. Certification by an accredited asbestos inspector indicating that no asbestos containing material is present or a copy of a Department of Health approved asbestos abatement plan.**
- 2. Letter from any utility company, with service to the structure stating that the utilities have been disconnected.**

Re: Building Demolition – Asbestos Containing Materials

The RI Department of Health' Asbestos Program has recently responded to several incidents involving a building or structure that is in the process of demolition for which asbestos containing building components had not been removed. Asbestos is a class A carcinogen, which for public health protection, must be safely handled and disposed. Asbestos may be present in a wide range of building materials such as pipe, boiler and tank insulation, plasters, flooring applications, exterior roofing and siding. We therefore would like to take this opportunity to clarify building owner responsibilities regarding asbestos identification and removal in these situations.

Federal and State regulations require that "prior to demolition, a building must be thoroughly inspected for the presence of friable and non-friable asbestos containing material". This inspection must be conducted by a person accredited in the identification of asbestos containing building materials. The RI Department of Health, Asbestos Control Program certifies asbestos inspector consultants who possess the necessary accreditation (current list enclosed.)

If asbestos containing materials are identified in a structure to be demolished, they must be removed by a RI licensed asbestos abatement contractor following an approved asbestos abatement plan. In the event of an emergency situation, such as a fire damage building or unsafe structure ordered demolished by the municipal building official, procedures are in place to expedite the process. However, the asbestos containing material must be handled by a licensed asbestos abatement contractor and properly disposed.

We are seeking your assistance in assuring asbestos containing materials are correctly identified and removed prior to a building's demolition. As a component of a demolition permit application to your Office, it is asked that you request a copy of a certification by an accredited inspector indicating that no asbestos containing material is present or that an asbestos abatement plan has been approved by the RI Department of Health for the removal of all identified asbestos containing material before demolition activities commence.



Re: Building Demolition

Federal Law (40 CFR 61 NESHAP Act) and State Regulations (R23-24.5-ASB Rules and Regulations for Asbestos Control) require that an applicant for a demolition permit present an asbestos survey or approved asbestos abatement plan as part of the application process to obtain a demolition permit. These regulations also require that all friable asbestos be abated prior to the demolition of the structure.

Prior instructions from this Office stated that this inspection must be performed by an individual that is certified through the Model Accreditation Plan of the Federal AHERA act (40 CFR 763) and licensed by This Department to provide those inspections.

As further clarification, and as a result of several recent incidents, this office is providing this additional guidance to local building officials.

Any asbestos surveys/inspections presented to obtain demolition permits that do not contain sample results should be referred to this office (stephan.mcdonagh@health.ri.gov, 222-7746) and the permit should be either denied or held under consideration until a determination is made by this office regarding the appropriateness of the survey/inspection.

Asbestos was used in over four thousand consumer products in the US and this includes many building components. **Licensed Asbestos Inspectors are never allowed to make a presumption of non-asbestos content of building products. In the absence of testing, all suspect materials must be assumed positive for the presence of asbestos.** An inspector's experience is not sufficient justification to preclude proper collection and analysis of suspected building materials. The Only acceptable reason to exclude suspect asbestos-containing material from the abatement process is laboratory analysis per approved methodology by a licensed, certified laboratory.
